**TITLE:** *Ingham County Announces that the 2007 Community Agency  
Grant Application Process has Begun*

### ***Mason, Michigan—***

Ingham County announces that the 2007 Community Agency grant application process has begun. Ingham County provides financial support to various community agencies that are primarily non-profit organizations. Often using volunteers, these organizations provide a variety of important services such as education, recycling, basic needs and housing to Ingham County residents. The Ingham County Board of Commissioners annually has an application process whereby eligible agencies may identify how they meet the County's strategic planning objectives, the amount of funds they are requesting, how they collaborate with other government or community agencies and how the County appropriation will leverage other sources of funds to meet the organizations and County's objectives. Ingham County Board of Commissioners' Chairperson, Victor Celentino, stated "for a

small County appropriation, these non-profit organizations working at the grass roots level can often leverage the county money with other funds and provide an excellent return on our investment in furthering our goals and objectives in providing services to County residents.”

The annual grant allocation process is tied into the County annual budget process and starts with an application for the agency to fill out that is due this year on June 16, 2006, 5:00 p.m... The applications are reviewed by County staff and legal counsel to make sure they meet the County objectives and legal restrictions on public funds. The various eligible applications then are segregated by function as to what liaison committee of the Ingham County Board of Commissioners would be most appropriate for funding consideration. The liaison committees are Human Services, Law Enforcement, Judiciary, and County Services. The actual funding recommendations then go from the liaison committees to the Finance Committee and onto the full Ingham County Board of Commissioners for approval through a County resolution. In FY 2006, approximately \$211,150 was made available to local organizations and agencies in support of the Board of Commissioners' priorities.
