 Resolution to Authorize Transferring Money to a Temporary Line Item in the Ingham County MSU Extension 2003 Budget to Create a part Time Project Coordinator to Provide Coordinating and Program Support Services to the Ingham County/City of Lansing Youth Violence Prevention Coalition

MOVED BY COMM. HERTEL, SUPPORTED BY COMM. SWOPE, TO APPROVE THE RESOLUTION TO AUTHORIZE TRANSFERRING MONEY TO A TEMPORARY LINE ITEM IN THE INGHAM COUNTY MSU EXTENSION 2003 BUDGET TO CREATE A PART TIME PROJECT COORDINATOR TO PROVIDE COORDINATING AND PROGRAM SUPPORT SERVICES TO THE INGHAM COUNTY/CITY OF LANSING YOUTH VIOLENCE PREVENTION COALITION.

In response to Chairperson Dedden, Mr. Neilsen explained the Michigan Council on Crime and Delinquency elected to terminate these services as of September 31, 2003 due to some contract confusion between the Council and the Youth Violence Prevention Coalition. He also informed the Committee that Ms. Shelly Bauer may be hired as the Project Coordinator.

MOTION CARRIED UNANIMOUSLY.

2. <u>Health Department</u>

a. Resolution to Authorize a Plan to Improve Dental Program Efficiency and Expand Dental Services

MOVED BY COMM. SWOPE, SUPPORTED BY COMM. HERTEL, TO APPROVE THE RESOLUTION TO AUTHORIZE A PLAN TO IMPROVE DENTAL PROGRAM EFFICIENCY AND EXPAND DENTAL SERVICES.

Mr. Bragg explained the Health Department operates two dental clinics. One clinic is focused on serving low-income, uninsured adults and the other clinic focuses on services to low-income and Medicaid eligible children. An outside review of the dental clinics has recommended a plan which would improve the operation of both clinics. Review recommendations include: improved access for patients, more patients being seen, more procedures being rendered, improvement of billing and cash collection and the generation of additional revenue. The Review also recommends the establishment of a system to better support the Dental Director who functions as a dentist and is responsible for administering two busy clinics.

Mr. Bragg further explained the youth clinic would greatly benefit from the proposed improved services. The cost of implementing the plan is \$111,832. Anticipated additional revenue from the Plan is \$190,575. Mr. Bragg's October 28, 2003 memorandum outlines how the Plan will result in increased revenue. The Plan calls for an additional half-time dentist in the dental clinic, an additional support staff person to be shared between the two clinics, a small amount of equipment that will help providers become more productive and a contract with Ms. Wheeler to provide ongoing support to Dr. Norris and the dental staff in implementing the Plan.

The Committee held a brief discussion regarding the financial implications of the proposed Plan. Mr. Bragg stated the Health Department's Plan is to increase revenue and expense by \$111,832. With the proposed Plan, nearly \$80,000 of uncommitted revenue will result. The Department will not spend the uncommitted revenue.

Chairperson Dedden commended Dr. Norris for the very detailed report she provided at an earlier meeting this year.

MOTION CARRIED UNANIMOUSLY.

b. Resolution to Authorize an Amendment to the 2003-2004 CPBC and Accept Federal Public Health Preparedness and Response for Bioterrorism Grant Funds

MOVED BY COMM. HERTEL, SUPPORTED BY COMM. CELENTINO, TO APPROVE THE RESOLUTION TO AUTHORIZE AN AMENDMENT TO THE 2003-2004 CPBC AND ACCEPT FEDERAL PUBLIC HEALTH PREPAREDNESS AND RESPONSE FOR BIOTERRORISM GRANT FUNDS.

In response to Comm. Weatherwax-Grant, Mr. Bragg further stated this Resolution should not result in the duplication of any services.

In response to Comm. Weatherwax-Grant, Mr. Bragg updated the Committee regarding the Small Pox vaccination matter. Approximately 10 Ingham County employees received the vaccination. This fell well below the Department's expectations. Approximately 60 Ingham Regional Medical Center employees have been vaccinated.

In response to Chairperson Dedden, Mr. Bragg stated the Bioterrorism Grant Fund involves federal funds. He also explained it is not limited to a terrorism outbreak. The funds may also be used for catastrophic infectious diseases such as pandemic influenza and other public health threats and emergencies.

MOTION CARRIED UNANIMOUSLY.

3. <u>Informational Item</u> - Ingham Health Plan Corporation Board of Directors and Contact List

Mr. Bragg informed the Committee that the County's Corporate Attorney has advised it is not proper for County officials or staff to be members of the Ingham Health Plan Corporation Board of Directors.

Comm. Swope expressed his concern that not all current members appear to reside or work in Ingham County. Mr. Bragg stated there is no requirement for Board members to live or work within the County. Comm. Swope suggested a specific number of members should be from Ingham County due to the funding implications. Mr. Bragg stated he would send the IHP Board a communication regarding Comm. Swope's concerns. He could also suggest that 80% of the Board be made up of Ingham County residents or employees within the County. Comm. Swope encouraged the IHP Board to be cognizant of this issue.

4. Community Mental Health Board - Appointments

After some discussion, the Committee made the following motion:

MOVED BY COMM. SWOPE, SUPPORTED BY COMM. WEATHERWAX-GRANT, TO RECOMMEND THE APPOINTMENT OF STEVE MANCHESTER TO THE COMMUNITY MENTAL HEALTH AUTHORITY. MOTION CARRIED UNANIMOUSLY.

The Committee expressed their hope that the next Human Services Committee will consider the remaining applicants (Patrick St. George and James Hughes) for future vacancies on the CMH Board. The Committee found all the applicants were very qualified to serve on the CMH Board or other commissions.

SUBJECT: Authorization to Accept a 0-3 Secondary Prevention Program Grant (JumpStart)

This is a recommendation to authorize a grant agreement with the Children's Trust Fund intended to improve maternal and child health and prevent child abuse and neglect. The JumpStart Family Outreach Program provides voluntary, intensive, long-term support and education to families through home visiting services using the Healthy Families America model. The Health Department worked with a coalition of public and non-profit agencies in the community to develop a proposal in response to a Request for Proposal issued by the Family Independence Agency. The proposal represents a continuation of the JumpStart Program.

The Children's Trust Fund has notified us that the proposal has been funded. The attached resolution will authorize the grant agreement. The State will provide up to \$133,450 during FY 2003-2004. The County, Ingham Regional Medical Center and the Strong Families Safe Children/Family Independence Agency will contribute to the cash match and in-kind match requirements. Sparrow Health System, the Intermediate School District, Community Mental Health, Head Start and other community agencies contribute to in-kind services and collaboration that makes the JumpStart services valuable.

This program and the grant funding are included in the Health Department's 2004 budget. I recommend that the Board adopt the resolution and authorize the contract.

WHEREAS, staff from the Ingham County Health Department has worked with persons representing other public agencies and community organizations to develop a proposal, in response to a Family Independence Agency request for a proposal, intended to develop services to reduce child abuse and neglect in Ingham County; and

WHEREAS, the coalition has recommended and the Ingham County Human Services Committee has supported the continuation of the Jump Start Program operated by the Health Department; and

WHEREAS, the Children's Trust Fund has advised Ingham County that the proposal has been funded for the period October 1, 2003 through September 30, 2004; and

WHEREAS, the Health Officer has recommended that the Board of Commissioners accept the grant award and authorize the grant agreement with the Children's Trust Fund and advises the Board that the local cash and local in-kind funds are already available in the Health Department's FY 2004 budget and have been committed by Ingham Regional Medical Center, Sparrow Health System and other community agencies.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners authorizes a 0-3 Secondary Prevention Grant Agreement with the Children's Trust Fund for Fiscal Year 2003-2004.

Grants

This is a recommendation to authorize two Teen Health Center Letters of Understanding with Baldwin Community Schools. Since the late 1980's the State of Michigan has provided grant funds to help support Peer Education provided through Willow Plaza Services. The State has helped support the Otto Middle School Community Health Center with grant funds since 1995. Originally the grant funds were provided through a grant from the Michigan Department of Community Health. A few years ago, the funding was changed to the Department of Education. The Department of Education can only contract with local school districts. It has designated Baldwin Community Schools as the fiduciary agent for the implementation of the Teen Health Center grants throughout the State.

The funds associated with these Letters of Understanding are anticipated in the Health Department's FY 2004 budget. One Letter provides \$73,200 to support the Peer Education Program through Willow Plaza Services. The other Letter provides \$123,200 to support the operation of the Otto Middle School Community Health Center.

I recommend that the Board of Commissioners adopt the attached resolution and authorize the proposed Letters of Understanding with Baldwin Community Schools.

Subject: Recommendation to Authorize a 2003-2004 CAP Grant Contract with the Ingham

Health Plan

This is a recommendation to authorize a subcontract with the Ingham Health Plan Corporation (IHPC) to make available to Ingham County funds to continue improvements in the organization of clinical services through the network of community health centers. The IHPC was awarded a \$315,073 Community Access Program grant for FY 2003-2004. This is the third year that the IHP has received grant funding from the Bureau of Primary Care, Health Resource and Services Administration, USDHHS. Much of the grant money will be subcontracted to Ingham County to develop the infrastructure that supports the growing statewide network of indigent health plans and to improve the efficiency of clinical services provided through the County's network of community health centers. The FY 2003-2004 subcontract with Ingham County is for \$223,073. The remainder of the funding goes out in subcontracts to purchase other services and for evaluation.

Most of the subcontracted \$223,073 is already included in the Health Department 2004 budget recently adopted by the Board of Commissioners. An exception is the \$34,610 payments to Sparrow Health System to help finance a \$74,610 renovation project at the County's Community Health Center in the Medical Center West Building on the corner of MLK Boulevard and Saginaw Street, on the St. Lawrence Campus of Sparrow Health System. Sparrow will contribute the \$40,000 to the renovation and updating.

I recommend that the Board of Commissioners adopt the attached resolution and authorize a subcontract with the Ingham Health Plan Corporation to implement the 2003-2004 Community Access Program grant. The resolution will also authorize the County to reimburse members of the Community Health Center Board for County related travel according to the County's travel policies and will authorize the Controller to amend the Health Department's 2004 budget.

RESOLUTION TO AUTHORIZE A 2003-2004 COMMUNITY ACCESS PROGRAM GRANT SUBCONTRACT WITH THE INGHAM HEALTH PLAN CORPORATION

WHEREAS, the Ingham Health Plan Corporation (IHPC) has been the recipient of a Community Access Program (CAP) grant since 2001-2002; and

WHEREAS, the purpose of the grant is to improve the quality of services of safety network health care providers and to expand the capacity of the safety network providers; and

WHEREAS, the Bureau of Primary Care, Health Resources and Services Administration, USDHHS has awarded a \$315,073 grant to the IHPC for FY 2003-2004; and

WHEREAS, the IHPC proposes a \$223,073 subcontract with Ingham County; and

WHEREAS, most of the \$223,073 is already recognized in the Health Department's 2004 budget; and

WHEREAS, the Health Officer has recommended that the Board of Commissioners authorize the CAP subcontract with the Ingham Health Plan Corporation.

THEREFORE BE IT RESOLVED, the Ingham County Board of Commissioners authorizes a Community Access Program grant subcontract with the Ingham Health Plan Corporation intended to improve the capacity and efficiency of the County's network of community health centers to serve low income, uninsured and Medicaid enrolled people.

BE IT FURTHER RESOLVED, that the subcontract shall be for the period October 1, 2003 through September 30, 2004 and that the IHPC shall make available to Ingham County up to \$223,073.

BE IT FURTHER RESOLVED, that the County is authorized to pay Sparrow Health System \$34,610 to support a \$74,610 renovation project at the County's Health Center located on Sparrow's St. Lawrence Campus, with Sparrow Health System providing \$40,000 toward the project.

BE IT FURTHER RESOLVED, that the Health Department is authorized to reimburse members of the Community Health Center Board for business related travel according to the Ingham County Travel Policy.

BE IT FURTHER RESOLVED, that the Controller is authorized to amend the Health Department's 2003-2004 budget to implement this resolution and the subcontract.

Subject: Recommendation to Amend the Clean Sweep Pesticide Collection Program

Agreement with the Michigan Department of Agriculture.

This agreement authorized a grant from the Michigan Department of Agriculture to support the construction of a household hazardous waste collection facility on the grounds of the Human Services Building. The building will allow more flexibility in the collection of household hazardous waste.

Additionally, the agreement with the Department of Agriculture provides for the State to reimburse Ingham County for the cost of pesticide and mercury collection and disposal when State funds are available for that purpose. The MDA is proposing to amend the existing agreement to provide up to \$20,000 in reimbursement during Fiscal Year 2003-2004.

RESOLUTION TO AMEND THE CLEAN SWEEP PESTICIDE COLLECTION PROGRAM AGREEMENT WITH THE MICHIGAN DEPARTMENT OF AGRICULTURE

WHEREAS, the Ingham County Board of Commissioners entered into a Clean Sweep Pesticide Collection Program Agreement with the Michigan Department of Agriculture, authorized in Resolution No. 01-254; and

WHEREAS, that agreement provided State funds to support the expansion of the Household Hazardous Waste Collection Program in Ingham County, including support for the construction of a prefabricated hazardous waste storage facility; and

WHEREAS, the Department of Agriculture has offered to amend the agreement to provide up to \$20,000 to reimburse Ingham County for costs associated with the collection, transport and disposal of pesticides; and

WHEREAS, the Health Officer has recommended that the Board of Commissioners amend the agreement and accept the additional funds.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners hereby authorizes an amendment to the Clean Sweep Pesticide Collection Program Agreement with the Michigan Department of Agriculture, authorized in Resolution No. 01-254.

BE IT FURTHER RESOLVED, that the amendment shall provide for Ingham County to receive reimbursement for up to \$20,000 from the Michigan Department of Agriculture for costs associated with the collection, transport and disposal of pesticides during the period October 1, 2003 through September 30, 2004.

BE IT FURTHER RESOLVED, that the Controller is authorized to amend the Health Department's 2004 Fiscal Year Budget to implement this resolution.

BE IT FURTHER RESOLVED, that the Board Chairperson is authorized to sign the amending document after review by the County Attorney.
